AFFILIATE AGREEMENT

Genesis Communications Network, In., a Minnesota Corporation, hereinafter called "GCN", and radio broadcaster
_____ herein after called "Broadcaster," hereby agree that:

(1) GCN will make all of the programs selected in the, "Program List," hereinafter called "Programming", available to Broadcaster on a market exclusive basis, unless this agreement is otherwise amended below. Broadcaster will air Programming each week on the dates and times for each individual program as stated on the, "Program List."

(2) Broadcaster provides a signed, dated copy of this affiliate agreement to GCN before broadcasting Program.

(3) Broadcaster does not defame or in any way cause harm to GCN.

(4) Broadcaster shall receive GCN programming via **(SELECT one or more)**:

- Live via XDS (Citadel) System**
- Live via GCN Streaming Internet Feed**
- Delayed via either XDS or Download (please circle one)**

(5) Broadcaster will notify GCN of permanent changes in Program broadcast time.

(6) This agreement applies to the following radio station(s): _____

(7) GCN may request that the broadcaster furnish GCN with a monthly affidavit documenting broadcast times of Programming, and noting any preemptions or rescheduling from normal broadcast time.

(8) Broadcaster agrees to broadcast Program in its entirety, including network commercials specified on GCN Program Clock.

(9) GCN agrees to allow the station exclusivity INlicensed market for the program(s) and time(s) stated on the "Program List."

(10) This agreement shall be in effect indefinitely from the date of signing below. GCN or Broadcaster may terminate agreement on 30 days written notice tendered by either party to the other.

(11) If GCN or Broadcaster fails to comply with these provisions or is unable to cure defects in this agreement within 10 days, the injured party may withdraw from this agreement by providing five (5) days notice to the other of their intent to end the relationship.

(12) The terms above represent the complete terms of agreement between GCN and Broadcaster, subject only to the amendments described below:
